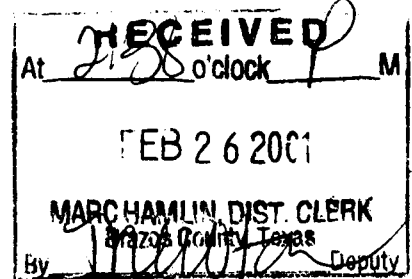

ORDER FOR CHANGE OF NAME

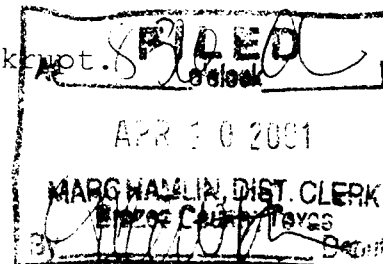


Upon consideration of the application for the change of name filed herein and no objections having been made and all other requirements appear having been met, the Court finds the following as facts:
