

GOOCHLAND COUNTY DEEDS AND WILLS

Will of John Phelps (x), sick, son John the use of the land where he (the son) lives, and at his death to his heirs; also one negro; to son Samuel the use of the land where James Stratford lives and at his death to his heirs, and also 6 negroes, also 500 acres on Fleamon's Creek, cattle &c; to son William the remainder of the land on Fleamon's Creek, 560 acres, and also land testator lives on (after the death of testator's wife), 3 negroes &c; to grandson John Phelps 54 acres and one negro; to grand-daughter Mary Phelps, one negro; granddaughter Sarah Phelps, one negro; wife Margaret, 3 negroes for her life and then to son William, the use of plantation where testator lives, &c &c; the negroes given grandchildren to be in the care of Wm. Phelps. Sons Samuel and William executors. Dated Feb. 14, 1747; proved in Goochland March 1747.

Before Oct. 1764, Susanna, widow of William Walton Sr., married Clayborn Rice, of Goochland Co., and Frances Walton, daughter of Wm. Walton Sr. married Henry Mullens, of Louisa County.

Deed, March 21, 1785, from Robert Lewis, of Goochland, to his son Howel Lewis, conveying 490 acres on Bird Creek, which said Robert Lewis lately removed from, and also 15 negroes.

Indentures, March 21, 1785, of Nathaniel Price, son of Meredith Price, deceased, binding himself, with consent of his mother Elizabeth Price, to David Ross, to learn the trade of merchant, storekeeper and accountant.

Will of Thomas M. Fleming, wife Ann Spotswood, son Tarlton, daughters Martha Dandridge, Mary Page and Ann Spotswood, Father-in-law Archer Payne one of executors. Dated June 22, 1800, proved in Goochland Sept. 21, 1801.

Deed, Feb. 15, 1802, from Robert Lewis of Goochland, conveying 12 slaves to his son Warner.

Inventory of estate of Robert Lewis Jr., deceased, March 1802.

Will of Nathaniel Massie, of Goochland, sons Nathaniel and Thomas all his lands in Kentucky; daughter Mary Robards has had her proportion of my estate; daughter Elizabeth Massie has had her proportion

Will of John Scott Jr, dated June 1729, proved July 21, 1730, legatees: brother Samuel and sister Jane Scott, sister Mary Scott, brother Edward Scott. All goods, moneys, dues, etc. in England or elsewhere, to Samuel Scott.

Deed January 1st 1731, from Thomas and Leonard Ballow, of Goochland, conveying land granted them in 1727.

Deed, Oct. 31, 1732, from Henry Chiles and Anne his wife, of Hanover, to William Mills conveying 300 acres in Goochland on Lickinghole Creek.

Deeds, July 1733, from Edward Curd, of Henrico, to his daughters Elizabeth Williamson and Mary Richardson.

Deed, Nov. 1733, from Edward Curd, of Henrico, bricklayer.

Deed, Nov. 6, 1733, from Judith Ballow, of Goochland, widow, to Peter Guerrant, conveying land devised to said Judith by her father Peter Chastain, deceased, in his will, dated Oct 3d, 1728.

Deed, Dec. 1, 1736, from Thomas Ballow, of Goochland, to his cousin Mary Patteson, of Goochland.

Deed, May 9, 1737, from Henry Chiles, of Goochland, to John Smith, of St. Pauls Parish, Hanover.

Deed, March 15, 1736, from John Phelps and Mary his wife of Goochland, to Thomas Phelps, of same.

Deed from Charles Hudson, of Hanover, gentleman, to Michael Woods, of Goochland, conveying 2000 acres in Goochland, which was granted to Hudson in 1735 (soon afterwards Woods conveyed the land back to Hudson).

Deed, Dec. 21, 1737, from Richard Parker and Judith his wife, of Goochland, conveying a tract in Deep Creek [Cumberland].

Bond of Arthur Hopkins, sheriff, Dec. 28, 1739.

Deed, April 1740, from Thomas Ballow, of Goochland, Carpenter.

Will of Henry Holman, dated April 10, 1739, proved Aug. 19, 1740, legatees: wife Mourning, son Nathaniel, wife pregnant, "Cousin" James, "son of my brother" James Holman.

Deed, June 16, 1741, from Theoderick Carter, of Gochland.

Will of Peter Ware, of Henrico, dated June 8, 1741, proved in Goochland, March 16, 1741, legatees: brother Henry Ware land in Goochland "which was willed to me by my father", wife Judith, son John, daughters Sarah and Judith, son Henry.

Deed from John Price (x) of Goochland, Sept. 23, 1749, to his son William Price, conveying 330 acres in Goochland, where said John Price lives.

Deed from Paul Chiles and Anne his wife of Albemarle County, June 22, 1750, to John Payne, of Goochland, conveying 200 acres on Little Byrd Creek.

Will of Anthony Gavin, clerk, dated Feb. 21, 1744-5, proved Sept. 18, 1750, whole estate to wife Rachel.
