2. All members who are not in good standing with their chapter or who have decided that they no longer wish to be a member in the Teamster Horsemen, Will turn in all patches (LOGOS) TO THEIR RESPECTIVE CHAPTER.
3. All Chapters who receive vest and patches (logo) intact shall have the right to resell the vest and patches (logo), as used, to new members, one half (1/2) of the monies for sale of a used vest shall be returned the original member provided he or she left in good standings the other one half (1/2) shall be deposited in the respective chapters treasury.

### ARTICLE 14. PROBATION PERIOD

**SECTION 1.** There shall be a nintey (90) to (180) day probation period for all new members, after which the Executive Board will confer with non-probationary members of the club. The Executive Board will then vote on whether to keep or dismiss the probationary member.

**SECTION 2.** Probationary members will be required to attend three (3) meetings following the date of his or her appllication, probationary members may be excused by the president of the Chapter from this rule only for good cause.

**SECTION 3.** Probationary members will not wear Full patches (Logo) while on probation (NO center back patch), but will be allowed to wear a Teamster Horsemen Support T-Shirt.
