## **BOARD OF DIRECTORS – AUTHORITY AND DUTIES**

THE BOARD SHALL NOT ENGAGE IN ANY ACTS CONSTITUTING A CONFLICT OF INTEREST. THE BOARD'S DUTIES INCLUDE, BUT ARE NOT LIMITED TO:

- 1) ENFORCING THE BYLAWS OF THE GREATER TYLER USBC BOWLING ASSOCIATION.
- 2) COMPLYING WITH THE USBC ASSOCIATION POLICY MANUAL.
- 3) ENSURING ADHERENCE TO ALL USBC PERFORMANCE STANDARDS.
- 4) CONDUCTING CHAMPIONSHIP LEVEL COMPETITION FOR ITS MEMBERSHIP CONSTITUENCY.
- 5) PROVIDING EDUCATION, TRAINING, EVALUATIONS, RECOGNITION AND OTHER SERVICES AS DETERMINED BY THE USBC.
- 6) IMPLEMENTING USBC PROGRAMS.
- 7) SELECTING/APPOINTING AND EVALUATING THE PERFORMANCE OF THE ASSOCIATION MANAGER.
- 8) APPROVING USE OF MEMBERSHIP RECORDS.
- 9) RE-RATING THE LEAGUE AVERAGE OF AN ASSOCIATION MEMBER WHEN THERE IS EVIDENCE THE BOWLER'S AVERAGE DOES NOT REPRESENT THE BOWLER'S TRUE ABILITY.
- 10) CONDUCTING SUSPENSION AND REINSTATEMENT HEARINGS.
- 11) ELECTING THE NOMINATING COMMITTEE BY MAJORITY VOTE.

### **BOARD ELIGIBILITY**

#### A CANDIDATE FOR THE BOARD MUST BE:

- 1) A USBC MEMBER IN GOOD STANDING OF THE ASSOCIATION AT THE TIME OF ELECTION AND THROUGHOUT THEIR TERM.
- 2) ELECTED OR APPOINTED WITHOUT REGARD TO RACE, COLOR, RELIGION, DISABILITY, NATIONAL ORIGIN, OR AGE, OTHER THAN THE MINIMUM AGE AS OUTLINED BY THE GREATER TYLER USBC BOWLING ASSOCIATION BYLAWS.
- 3) BE CURRENT ON ALL LEAGUE AND ASSOCIATION DUES, FEES, AND LINEAGE.
- 4) BE ABLE TO ATTEND BOARD MEETINGS, MOST OF WHICH ARE ON SATURDAY MORNINGS.

#### A CANDIDATE FOR THE BOARD MUST HAVE:

- 1) BEEN A MEMBER OF THE GREATER TYLER USBC BOWLING ASSOCIATION FOR TWO YEARS.
- 2) ATTENDED 2 OUT OF THE LAST 5 ANNUAL MEETINGS.
