## **TOURNAMENT RULES**

1. Handicap will be 80% of the difference between the bowler's average and 220.
2. The following average will be used, based on minimum of twenty-one (21) games bowled within the Greater Tyler USBC:
  - A. Highest 2008-2009 winter league average.
  - B. Highest December 31, 2009 average if no previous season average.
  - C. Highest summer 2009 average if no winter average is available.
  - D. Highest average as of January 1, 2010, only if none of the above applies.
  - E. All others bowl scratch.
3. It will be each entrant's responsibility to determine that the submitted average is correct. Failure to use proper average, or to make correction prior to completion of the first game of a series, shall disqualify score if submitted average is lower than actual average. Prize winnings will be based on submitted average if higher than actual average.
4. Tournament Committee reserves the right to re-rate any bowler prior to bowling. If bowler refuses the re-rated average, entry fee will be returned. Entrants have the right to appeal any re-rates to USBC within fifteen (15) days after bowling, or prior to payment of prize fund, whichever comes first.
5. A bowler must submit an adjusted average to Tournament Committee if, during the last twelve (12) month period prior to this tournament his/her accumulated average of all, but not less than twenty-one (21) tournament games exceeds average used for entry by more than fifteen (15) pins.
6. Non-members living within the jurisdiction of the Greater Tyler USBC who are not members of another association may enter by paying an unattached membership fee. All members of the Greater Tyler USBC are eligible.
7. All prize money will be awarded equally to the youth members of the team, and deposited into their Smart Fund account.
8. A tournament game or frame(s) irretrievably lost in scoring process may be re-bowled. Decision of tournament management shall be final except where appeal is made to USBC for further consideration.
