Spectrum Protection Act co-sponsor list takes a giant step

Encouraging news this week from Washington: The list of House co-sponsors for the Amateur Radio Spectrum Protection Act, HR 713, has reached 69. ARRL President Jim Haynie, W5JBP, says he's pleased with the progress since mid-October, when he'd expressed his frustration over a lack of cosponsors. Since that time, the list has grown by 17 representatives. The Senate version of the legislation, S 537, is holding at eight co-sponsors.

"I'm cheered up that we've got new representatives to sign on, but we can't just stop," Haynie said. "We gotta keep at it." He said the League has been concentrating its efforts on promoting HR 713 because the bill has the best chance for success of any Amateur Radio-related legislation now before Congress.

Haynie continues to encourage ARRL members to not only urge their senators and representatives to cosponsor HR 713 and S 537 but to write and ask them to actively support them. "This is something that's important to the future of Amateur Radio," Haynie reiterated.

Sponsored in the House by Rep Michael Bilirakis (R-FL) and in the Senate by Sen Michael Crapo (R-ID), the Spectrum Protection Act would require the FCC to provide "equivalent replacement spectrum" to Amateur Radio if the FCC reallocates primary amateur frequencies, reduces any secondary amateur allocations, or makes additional allocations within such bands that would substantially reduce their utility to amateurs.

HR 713 has been referred to the

Subcommittee on Telecommunications and the Internet. Haynie testified before that panel in June. S 537 has been referred to the Committee on Commerce, Science, and Transportation.

For the convenience of those writing their representatives and senators to urge cosponsorship of the Amateur Radio Spectrum Protection Act of 2003, sample letters are on the ARRL Web site. For guidance on the best methods of contacting your members of Congress, see "Communicating with Congress," by Derek Riker, KB3JLF, on the ARRL Web site or in the April 2003 issue of QST (p 46).

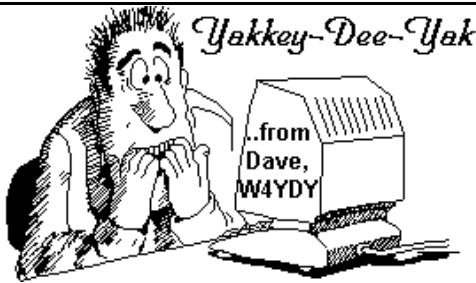

FCC mulls responses to complaints

It's hard to believe that another year has passed. Where does the time go? The FCC is considering the explanation of a Maryland ham in the wake of complaints that he disrupted an Amateur Radio Emergency Service (ARES) net in September during Hurricane Isabel. FCC Special Counsel for Enforcement Riley Hollingsworth wrote Charles E. Cox Sr, **WA3AE**, on October 16, enclosing complaints alleging deliberate interference to emergency communications conducted on 2 meters by **W3AAC** at the Anne Arundel County emergency operations center.

"The allegations, if true, raise serious questions about your qualifications to be a Commission licensee and warrant enforcement action," Hollingsworth told Cox. The US Postal Service returned the FCC's certified letter to Cox as undeliverable. Commission personnel eventually tracked him down to a residence in Laurel, Maryland.

In a handwritten note, Cox told the FCC that he was on the air, but he asserted that he was only trying to help and didn't believe he was interfering with the emergency net. "There is a major misunderstanding," Cox wrote, adding that he felt the situation was being blown out of proportion. Cox also said he would change his mailing address with the FCC.

Several complainants--two off-duty FCC employees among them--tell a different story. A station identifying as **WA3AE** came on the net and uttered "irrelevant comments many times," according to one net control station, who also said that the operator was rude, "seemed intoxicated" and used inappropriate language. Cox told the FCC he has a speech impediment that makes him sound inebriated. The NCS contended that Cox ignored numerous requests to keep the frequency open for emergency communications, but Cox disputes that.

Hollingsworth said the FCC has Cox's response to the complaints under review.

The FCC also is reviewing a response from a California licensee. On October 15, Hollingsworth wrote Angel Carballo, **KG6QKR**, of Fremont enclosing a complaint alleging interference on 2 meters during a two-hour period. The complainant told the FCC that two repeaters in the south San Francisco Bay area "were being kerchunked." The amateur who complained said he was able to track the source of the interfering signal to an unoccupied vehicle sitting in a corporate parking lot. He said the transceiver appeared to be in cross-band mode, and he was able to spot the transceiver's display blink momentarily each time the repeaters were accessed.

After the complaining amateur approached corporate security and threatened to report the incident to the FCC, security personnel asked him to hold off while they tried to "solve the problem internally." The complainant, whom the FCC did not identify, said security subsequently brought out a man who went to the vehicle and shut down the transceiver. The FCC apparently was able to locate Carballo through the license plate and vehicle description the complainant provided.

In an October 25 reply to the Commission, Carballo told the FCC he believes he "made a mistake" setting up his radios and did not intend to maliciously interfere. He indicated that he had set up his mobile transceiver as a cross-band repeater on VHF and UHF frequencies--one of them 146.94 MHz--and monitored both frequencies from a handheld transceiver in his office.

Carballo said his transceiver is not capable of transmitting on two frequencies within the same band, so he could not explain the interference to the 146.23 machine. He also offered his apologies and asked the FCC to extend them to the complainant as well. - *via ARRL Letter Online*

FCC reorganizes Wireless Telecommunications Bureau

The FCC has announced a reorganization of its Wireless Telecommunications Bureau (WTB) <<http://wireless.fcc.gov/>> "to more effectively support the FCC's strategic goals--broadband, competition, spectrum, media, homeland security and modernizing the FCC." The WTB administers the Amateur Radio Service (Part 97) and amateur licensing, but the changes are expected to be transparent to the amateur community. The Amateur Service now will be administered by the newly named Public Safety and Critical Infrastructure Division. D'wana Terry, formerly chief of the Public Safety and Private Wireless Division, will head the new division.

"The bureau's portfolios have been redistributed along the lines of strategic goals, consolidating similar functions to focus resources better," the FCC said in a November 24 public notice. As a result of the reorganization, which the FCC approved November 13, WTB expands from five to six divisions: Public Safety and Critical Infrastructure, Spec-

trum Management Resources and Technologies, Auctions and Spectrum Access, Spectrum and Competition Policy, Mobility, and Broadband.

In addition to the Amateur Service, the Public Safety and Critical Infrastructure Division will oversee Part 95, Marine, Aviation, Intelligent Transportation Systems, Public Safety Fixed Microwave, Public Safety and Private Land Mobile services and E911, among other areas. Responsibilities moved elsewhere include Fixed Microwave (Part 101), Instructional Television Fixed Service, the Multipoint Distribution Service, and the Multichannel Video Distribution and Data Service.

The action reduces the scope and size of WTB's larger divisions and eliminates separate branches below the division level, while retaining their current functions. One of those was the Licensing and Technical Analysis Branch, headquartered in the FCC's Gettysburg, Pennsylvania, office. Among other tasks, that branch has handled the granting and issuance of Amateur Radio licenses and the vanity call sign

program. Another was the Policy and Rules Branch at FCC Headquarters, which has been the home of Bill Cross, W3TN, an FCC figure well-known within the amateur community. Among other tasks, that branch has handled Amateur Radio rule making petitions and Part 97 rules interpretations.

A potential plus of the new arrangement is that Cross now will work under another amateur licensee, Mike Wilhelm, WS6BR, who will report to Terry.

The FCC said eliminating branches would promote greater management flexibility in deploying resources and lead to a flatter, more flexible organization without altering the bureau's overall mission. The Commission said it was able to carry out the reorganization by redeploying existing positions.

WTB Chief John Muleta said the reorganization will result in "a mission-driven team that will be innovative in its approach to regulatory policies and customer service." *via ARRL Letter Online*

Rohn announces asset purchase agreement

Amateur Radio and telecommunications industry tower manufacturer ROHN Industries <<http://www.rohnnet.com/>> has announced that it's entered into an asset purchase agreement with SPX Corporation <<http://www.spx.com/>>, a global, multi-industry company. ROHN filed September 16 for Chapter 11 (debtor-in-possession) relief in the US Bankruptcy Court for the Southern District of Indiana. The deal will include ROHN subsidiaries that are party to the bankruptcy proceeding.

"The asset purchase agreement provides for the sale of certain assets of the company and the affected subsidiaries to SPX Corporation for the amount of \$5,450,000," ROHN said in a news release.

Through its Broadcast and Communication Systems and Services division, SPX provides analog and digital TV and FM systems, high-frequency and medium-frequency antennas, transmission lines, towers and radio frequency filter systems for the broadcast market. SPX also is a major site developer for the PCS/cellular in-

dustry.

The bankruptcy court must approve the ROHN-SPX agreement. ROHN filed an amended motion with the court November 13 seeking the court's approval of the asset sale and authority to sell the assets "after an opportunity is provided for competitive bidding." A hearing to consider proposed bid procedures is scheduled for November 25, and the bidding auction is set for December 8. The bankruptcy court is to consider approval of the asset sale December 9.

In addition to its other products and services, ROHN manufactures towers, antenna support structures and "infrastructure equipment" for the telecommunications industry. Horace Ward is ROHN's chief executive officer. The company consolidated its manufacturing operations in Frankfort, Indiana, earlier this year.

National Radio Emergency Network to debut

The National Radio Emergency Network (NREN) <<http://www.aa8vs.org/nren/>> will commence operations December 1. A cooperative effort of several US CW net managers, NREN hopes to provide an alternative public service network geared to low-power, portable and mobile stations. "Because CW provides significantly more reliability for stations operating at low power levels (QRP) or with compromise antennas, this will be a CW-based program," said an announcement from Chuck Mabbott, AA8VS. NREN will work on the "radio watch" principle, and member stations will maintain a watch on one or more of three selected frequencies in the 40, 30, and 20-meter bands. ARRL sponsors BPL gathering for communications

The interference potential of Broadband over Power Line (BPL) to over-the-air radio services was the topic of an ARRL-sponsored meeting of 25 communications professionals November 7. The National Association of Broadcasters hosted the gathering at its headquarters in Washington, DC.

"Listening to everyone introduce themselves and explain why they had come made the trip to Washington worthwhile all by itself," said ARRL CEO David Sumner, K1ZZ, who offered opening remarks and guided the discussion. Sumner showed excerpts from the ARRL BPL field test videos, which graphically demonstrate that BPL's interference potential at HF is real, not just theoretical.

During the meeting, representatives from the shortwave broadcasting, public safety, aeronautical and scientific communities joined amateur and amateur-satellite representatives to discuss the threat of BPL and possible avenues to combat its interference potential to licensed HF and low-VHF spectrum users. Military and consumer electronics representatives participated as observers. Coming the farthest was Chip Margelli, K7JA, who attended on behalf of the Yaesu Amateur Division of Vertex-Standard.

ARRL General Counsel Chris Imlay, W3KD, reviewed the status of last April's FCC's Notice of Inquiry on BPL and noted that more than 5000 comments

were filed with the Commission--most of them from Amateur Radio operators. Imlay said that proposed FCC rules changes could come as soon as early next year.

Imlay added that a number of non-amateur organizations support ARRL's position on BPL. Representing the National Association of Shortwave Broadcasters, George Jacobs, W3ASK, affirmed their strong support for the ARRL position.

ARRL Technical Relations Manager Paul Rinaldo, W4RI, provided a technical review of BPL. BPL delivery systems would use existing low and medium-voltage power lines to distribute Internet and other broadband services to homes and businesses.

Other points the group touched upon included:

* BPL emission measurements by government agencies are under way, but the results have not yet been made public. The FCC denied an ARRL Freedom of Information Act request on the grounds that their test results represent work-in-progress.

* A government representative observed that concerned groups should be wary of tying in the overused term "homeland security" with any anti-BPL campaign, since it could be spun back against BPL opponents.

* Meeting attendees cited numerous and increasing instances of interference from Part 15 devices, suggesting that such in-

stances only infrequently result in complaints to the FCC--and even less frequently in any FCC action.

A follow-up meeting may be held early next year if it becomes clear that the FCC intends to release a Notice of Proposed Rulemaking regarding BPL. Some attendees indicated a willingness to accompany ARRL representatives to meetings with federal officials to underscore that concerns about BPL are not confined to radio amateurs.

"It's apparent that concerns about BPL run very deep and include nearly every over-the-air radio service," Sumner remarked after the meeting. "Now we can work together much more effectively to express our concerns both inside and outside of government."--Derek Riker, KB3JLF, compiled information for this report. *via ARRL Letter Online*

the HF signal out of the car. One area he has failed to make progress is to convince Anne, his wife, to put a radio in her car.

He has done some upgrading in his back yard, not flowers or bushes, - antennas. His dipole has had 160 meters added to the 80/40. His tribander has been upgraded to include the WARC bands of 12 and 17 meters. He still has the 2 meter beam and added a 3 element 6 meter beam.

He doesn't use packet much anymore, but has gotten into PSK31 and RTTY and while continuing SSB, he has increased his CW work.

To keep track of his on air activity he has two computer logs. The PDA LOGic 6 shows a total of over 55,600 contacts to date. The Counter Hunters computer log is specialized for his County Hunter activity. Technology has not completely taken his logging activity. He still maintains a paper log on all of his HF contacts. He is just about to fill his 47th book with each one holding about 1,250 contacts (he will use 10 books this year alone). This year so far he has made 11,587 contacts and expects to make 12,000 contacts for the year. His previous high was in 2001 with 10,420 which was double the previous record set in 2000. In his first 39 years of operating, his total number of contacts was 14,231 before he retired and moved to Greenville in 1992. Since then he has added over 41,000 more including over 2700 from the new mobile in the last 1 1/2 years. Retirement must be nice!

With all this activity you would him to have accomplished something. He did. He has gotten the WAS Award. Since 1998 he got the 100 countries to get the DXCC and now has 282. He has worked the 40 zones to be awarded the WAZ award sponsored by CQ magazine. IARU/ARRL has honored him with the WAC (Continents) award. World Radio magazine has gave him an award for having contacts with 100 different nations. The "31 on 31" is an award for making 31 contacts using PSK31 (his total now is 57) - the award number is 36. He is the second person to get the WANC Award. It is the Worked All North Carolina (counties) sponsored by the Forsyth

Amateur Radio Club. The 3905 Century Club Award is for getting 100 points on each of 160, 75 and 40 meters. He's gotten the ARRL Friendship Award. He has gotten two millennium awards: the 2000 DXCC Millennium Award from ARRL he contacted 100 countries in 2000. He did it in 10 days. He was one of 24 to get the CQ Millennium Award in 2001 for contacting 100 countries (CQDX); contacting 400 different prefixes (CQWPX); working 500 counties during the year (USACA) and working all 40 CQ Zones during the year (WAZ). For this he was in an article in CQ March 2003. (This was his third time being in CQ. The other times were February 2003 and in July 1953.). He also received the 10/10 number of 72671 which he could have gotten years ago.

On May 31, 2002 he receive the Worked all Counties Award for having made contact with each of the 3,077 counties in the 50 states. His award is number is 1069. An article in the October 2003 CQ Awards column covered that activity. He has restarted over and is only 354 from doing it again.

One of his most exciting contacts was on PSK31 when on November 5, 2001, he became the first person to communicate with the South Pole via the new PSK31 mode. They has just got PSK31 working and Dave answered the CQ not knowing it was the first PSK31 transmission from the South Pole. He received a QSL card postmarked "South Pole" from them a week later for confirmation of the first South Pole PSK31 contact.

Dave has not just been sitting in front of his rig. Each year he is an instructor for the Technician License Course, is an active Volunteer Examiner, participated in Field Day, has taken the SkyWarn Spotter Class several times, was in a couple of shelters for 3 days during the Floyd Flood in 1999. He has built his own interface for PSK31 which can also be used for RTTY and MFSK.

He receive the BARC Ham of the Year Award in 2001 and has been the Editor of Ham Chatter since June 1997 and is the web master of the BARC website. Every where I go I hear complements about the Ham Chatter and the web

On-line licensing course, lobbying kit part of ARRL's 2004 plan

An on-line Amateur Radio licensing course--possibly bundled with ARRL membership--plus additional Certification and Continuing Education courses <http://www.arrl.org/cce/> are among the strategic objectives of the League's 2004 Operational Plan. The League also plans to evaluate its existing ARRL on-line class offerings. The item was among several the ARRL Executive Committee (EC) designated to include in next year's plan when it met November 9 in Irving, Texas. Work on the licensing course already is under way, and the ARRL expects to announce its availability in the near future.

At a mid-September strategic planning session, ARRL Board members agreed to let the EC pick the 2004 objectives to incorporate into the 2004 Operational Plan. In the future, the full Board will handle the task. Other strategic objectives include development of a grassroots lobbying kit for ARRL members to use when approaching congressional representatives in their home districts on legislation affecting Amateur Radio and surveying served agencies such as relief organizations to identify their present and

future emergency communications requirements and areas of Amateur Radio performance that may need improvement.

The EC included some bottom-line related strategic objectives: That the League operate profitably to insure its future well being, and that it develop as ARRL Board policy a requirement that all new programs and services have a business plan and at least break even financially.

In other matters, ARRL CEO David Sumner, K1ZZ, told the EC that the League is close to signing a contract calling for independent testing and measurement of Broadband over Power Line (BPL) interference characteristics. Earlier this year, the FCC issued a Notice of Inquiry, ET 03-104, that enthusiastically endorsed the prospect of BPL, which the ARRL and others feel poses the potential of possibly severe interference to licensed HF radio services. The contract would include certification by professional engineers.

The EC discussed and developed draft proposals to implement changes in US Amateur Radio rules in the wake of World Radiocommunication Conference

2003 (WRC-03). Among other significant changes, WRC-03 left it up to individual countries whether to require a Morse code test for access to amateur high-frequency allocations. The ARRL Board of Directors will discuss the EC's recommendations in detail at its January 2004 meeting.

The EC also voted not to go forward with an appeal of FCC actions to permit expanded unlicensed Part 15 operations in the 24.05-24.25 GHz band. The ARRL had filed a Petition for Review October 22 with the US Court of Appeals for the District of Columbia Circuit of two FCC orders that would allow certification of unlicensed 24-GHz equipment at field strengths 10 times the level Part 15 rules now permit. After discussing the pros and cons of the case and the minimal prospects for a positive outcome, the Executive Committee voted to withdraw the League's appeal.

FCC Commissioner's office clarifies "Broadband Nirvana" remarks

The office of FCC Commissioner Kathleen Q. Abernathy <http://www.fcc.gov/commissioners/abernathy/> has expressed regrets that her remarks in a September speech may have failed to make Abernathy's concerns sufficiently clear about potential interference from Broadband over Power Line (BPL).

"We regret that the Commissioner's remarks may have been interpreted as suggesting an absence of concern over harmful interference," said Abernathy Senior Legal Adviser Matthew A. Brill, responding to complaints from the ARRL and individual amateurs. From a policy perspective, Brill said, Abernathy is "keenly interested" in seeing multiple broadband platforms develop, but that she didn't intend to suggest that BPL "necessarily will emerge as a viable platform or that it does not present interference issues."

In her speech to the United Pow-
erline Council's <http://www.uplc.utc.org/>

> annual conference September 22, Abernathy expressed unabashed enthusiasm for BPL and suggested it was a step along the pathway to "Broadband Nirvana." Brill noted, however, that near the end of her remarks, Abernathy--referring to the FCC's approach to PCS regulation--said the Commission was "right to adopt strict interference rules to prevent competitors from externalizing their costs. The same principle will apply to BPL."

Brill assured the ARRL that "ensuring that BPL and all new technologies avoid causing harmful interference to licensed RF users is a bedrock position for Commissioner Abernathy." He issued similar responses on Abernathy's behalf to several amateurs who had challenged her stance (see "ARRL Rebukes FCC Commissioner's BPL-Related 'Broadband Nirvana' Remarks" <http://www.arrl.org/news/stories/2003/09/25/100/>).

ARRL Chief Executive Officer David Sumner, K1ZZ, expressed delight at

Abernathy's recent clarification. Commissioner Abernathy's affirmation of this important principle as a 'bedrock position' is most welcome and reassuring news," he said. From the outset of the FCC's BPL Notice of Inquiry in ET Docket No. 03-104 last April, Sumner said, the League's goal has been to hold the FCC to its statement in the NOI that "each of these authorized services in the spectrum [including the Amateur and Amateur-Satellite services] must be protected from harmful interference."

"Since that time the presence of harmful interference at BPL test sites has been thoroughly documented," Sumner noted, "confirming that our original concerns were well founded."

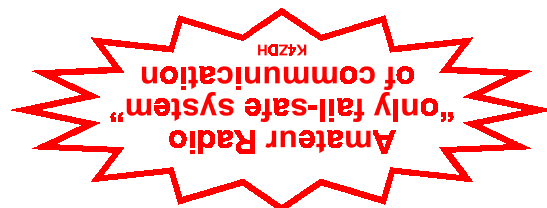
